# **Accelerated EMT Program Eligibility**

Emergency Medical Technicians or EMTs provide basic emergency medical care and transportation for critical and emergent patients who access the emergency medical system. This individual possess the basic knowledge and skills necessary to provide patient care and transportation. Emergency Medical Technicians function as part of a comprehensive EMS response, under medical oversight. Emergency Medical Technicians perform interventions with the basic equipment typically found on an ambulance. The Emergency Medical Technician is a link from the scene to the emergency health care system. The process of becoming an EMT in Virginia requires the following:

- Be proficient in reading, writing and speaking the English language.
- Be a minimum of 16 years of age at the beginning date of the EMT course. If you are
  less than 18 years of age, you must provide your instructor with a completed parental
  permission form with the signature of a parent or guardian verifying approval for
  enrollment in the course.
- Have no physical or mental impairment that would render you unable to perform all practical skills required at the EMT level.
- Hold current certification in an Office of Emergency Medical Services approved cardiopulmonary resuscitation (CPR) course at the beginning date of the EMT course. This certification must also be current at the time of state testing.
- Not have been convicted of or found guilty of any crime, offense or regulatory violation, or participated in any other prohibited conduct identified in state EMS regulation 12VAC5-31-910.
- Be clean and neat in appearance.
- May not be under the influence of any drugs or intoxicating substances that impairs
  your ability to provide patient care or operate a motor vehicle while in class or
  performing clinicals, while on duty or when responding or assisting in the care of a
  patient.

# **Accelerated EMT Program Information**

Dress code for the course will be business casual. You will need a plain white polo and Blue (5.11 like) pants for your ride-alongs. There is a \$50 VA State test fee that you are responsible for. Upon successful enrollment we will send you a confirmation letter that has a discount code that can be used when purchasing your book. Should you have any concerns about hotel stay we can provide you hotel information with a discounted rate code.

Class is scheduled for 0800-1800, however this is based on class size (the Commonwealth of Virginia is a content rather than an hour requirement state). Once the class has started it will be every day for 17 continuous days. We will schedule you with a local EMS company for your clinical/ ride-alongs, however you may ride with your own department if you so wish. For the EMT course there are NO immunization requirements.

You are taking an Virginia approved EMT course, after successful completion of the course you will be awarded an Eligibility to Test Letter. You may take that letter to a VA Psychomotor Exam. Once you have passed your Psychomotor Exam with VA you are eligible to take your Cognitive test with Pearson VUE for NREMT. Once you have successfully passed the Cognitive test you will be a Nationally Registered EMT and a Virginia EMT.
